## About the facilitators

Arlyn Anderson, CI & CT, brings over twenty years of interpreting experience and a lifetime of curiosity about mental and behavioral health to her work as a mental health interpreter, consultant, author and presenter. Her interest in mental health and interpreting has created opportunities to present, publish and explore the development of a holistic, comfortable, replicable approach to interpreting in mental health settings. Arlyn received her ASL and interpreting education at Vista and Ohlone Colleges in the San Francisco Bay Area and recently completed her BA from Metropolitan State University in St. Paul, MN, in Mental Health and Deaf Studies. Among her rich and varied interpreting experiences, Arlyn credits the staff position she held at Ross Hospital, a small psychiatric facility in Northern California, as laying a solid foundation of mental health interpreting experience though work with Deaf and hearing clinicians serving children, adolescents and adults under one roof. Arlyn is one of the authors of the RID Standard Practice Paper on Mental Health Interpreting and is the author of MENTAL HEALTH INTERPRETING, a 16-week mentored curriculum for New Mexico Mentoring. In addition to owning and operating ID Matters, Arlyn currently maintains a private interpreting and consulting practice specializing in individual, group, family therapy and psychoeducation.

Dan Langholtz, CDI & LCSW, is a longtime colleague, consumer, friend, and supporter of interpreters. He holds a BA degree in social work from NTID/RIT, an MA degree in social work from New York University, and is a licensed social worker. He has been with the University of California Center on Deafness in San Francisco for 25 years, doing both clinical work and training in the area of mental health and deafness. He also serves as a consultant in the fields of mental health, interpreting, HIV/AIDS, accessibility, and relationships between Deaf and non-deaf people. He also holds CDI and CLIP-R certification from RID, and has worked for many years within teams of Deaf and Hearing interpreters in a variety of settings such as courts, medical and social.
